General	<ul style="list-style-type: none">▪ Only Houses of Worship or Associations, gazetted under Lembaga Amanah Khairat Bukan Islam under the Charitable Trust Ordinance 1994 or registered with the Department of Registration of Malaysia (ROS) under the Societies Act 1966 (Act 335) are allowed to organise the festival▪ Unless the festival is organised in their own temple or premise, organisers are required to obtain a permit from the Local Authorities if their venue is in a public area
Notice Of Organising	<ul style="list-style-type: none">▪ The festival is allowed from 8th August 2021 to 6th September 2021 between 6.00 am and 10.00 pm only▪ The Notice of organising the festival shall be made to the Unit for Other Religions (UNIFOR) using Form NRP/P2/HGF21▪ This form can be submitted to UNIFOR by post, fax or email at the following address: Unit for Other Religions (UNIFOR), Chief Minister's Department 4th Floor, Wisma Satok, Jalan Satok 93400 Kuching, Sarawak Fax : 082-550566 Email : unifor@sarawak.gov.my

Maximum Capacity Of Attendance	The maximum attendance, after taking into consideration the size of the venue and one (1) meter of physical distancing, shall NOT BE MORE THAN 50 persons for indoor venues or 100 Persons for outdoor venues at any one time
Health Care Practices	<ul style="list-style-type: none">▪ Committee members on duty must be fully vaccinated▪ Unvaccinated individuals are not allowed to participate in the festival▪ Individuals below 18 years old are not allowed to attend the festival▪ Senior citizens 80 years old and above are not encouraged to attend the festival▪ Individuals showing symptoms of fever, cough or having breathing difficulties are not allowed to attend the festival.▪ Those with comorbidity are advised to take precautionary actions and are not encouraged to attend the festival▪ Sanitisation of the venue must be done before and after the festival▪ Proper ventilation of the venue must be ensured at all times
Prohibited Activities	<ul style="list-style-type: none">▪ Eating and drinking activities as well as activities involving physical contacts are strictly prohibited

Practices Before, During and After The Festival

Before

- The respective temple or association is to determine the schedule or time-table for the festival
- The organising committee is to prepare a registration counter to:
 - check the risk status or proof of vaccination of participants
 - take the temperature of all personnel on duty and participants attending
 - ensure that all personnel on duty and participants wear face mask
 - ensure that physical distancing is adhered to at all times
- Participants must wash their hands with soap and water or *hand sanitisers*
- Participants **must record their attendance** using the *MySejahtera* application or by filling in the attendance book provided

During

- Participants must sit or stand at **designated areas only**

After

- Participants must leave the venue in an orderly manner
- Socialising is not encouraged
- The organising committee is to sanitize the venue
- The organising committee must maintain the cleanliness of the venue

Responsibilities Of Participants	Participants are to: <ul style="list-style-type: none">▪ adhere strictly to the festival's schedule or time-table▪ wear face mask at all time and avoid physical contact with other participants▪ record their attendance through the MySejahtera application or by filling in the attendance book
Responsibilities Of The Organising Committee	The Organising Committee must: <ul style="list-style-type: none">▪ determine the festival's schedule or time-table▪ sanitise the venue, before and after the festival▪ ensure that the venue has good ventilation▪ check the risk status or proof of vaccination of all participants▪ ensure that participants enter through one entrance and exit through another▪ ensure physical distancing of at least one (1) meter is maintained at all times▪ make available hand sanitisers or soap and water at the entrance▪ ensure all participants wear face mask at all times▪ check the body temperature of all participants and personnel on duty▪ ensure participants record their attendance using the mysejahtera application or by filling in the attendance book▪ maintain the cleanliness of the venue▪ appoint at least two personnel to monitor and ensure that the sop is adhered to

概括	<ul style="list-style-type: none">▪ 只限于在1994年慈善信托法令下非伊斯兰慈善信托机构宪报颁布，或依据1966年社团法令(335条文)已向社团注册局注册的庙宇才被允许举办盂兰盆节胜会。▪ 规定在各自的庙宇或场所内举办盂兰盆节胜会，若在公共场所举办则必须向有关地方政府申请准证。

出席人数上限	<ul style="list-style-type: none">出席人数上限必须是以活动场地可容纳人数，及可有效实施至少一米之社交距离为考量，并确保在同一时间的出席人数不得超过50人(室内场所)或100人(室外场所)。
卫生准则	<ul style="list-style-type: none">执行胜会之工作人员必须已完全接种冠病疫苗。未接种冠病疫苗者一律不允许参与胜会活动。年龄少于18岁者一律不允许参与胜会活动。乐龄人士年龄于80岁及以上者不被鼓励参与胜会活动。任何参与者若有发烧、咳嗽或呼吸困难的症状，不得出席参与胜会活动。患有慢性疾病的人士必须采取预防措施及不被鼓励参与胜会活动。胜会活动场所必须在活动之前与之后进行消毒。必须确保胜会活动场所空气流通。
不被允许的活动	<ul style="list-style-type: none">胜会活动场所范围内严厉禁止任何饮食活动，包括任何涉及肌体触碰的活动。

胜会活动之前、
期间与之后的
操作准则

胜会活动之前

- 举办胜会之庙宇或组织必须确定胜会活动之流程或时间表。
- 主办单位必须设立注册柜台，以：
 - 检查参与者的风险评估及接种冠病疫苗的纪录。
 - 为所有工作人员与参与者测量体温。
 - 确保所有工作人员与参与者佩戴口罩。
 - 确保人群遵守社交距离。
- 参与者必须使用肥皂或消毒搓手液清洗双手。
- 参与者必须透过MySejahtera手机应用程序，或在所提供的记录簿上登记出席记录。

胜会活动期间

- 参与者只可以在规定好的范围内就座或站立。

胜会活动之后

- 参与者必须有秩序地离开胜会活动场所。
- 不鼓励有任何社交活动。
- 主办单位必须为场所消毒。
- 主办单位必须维持活动场所的整洁。

参与者的责任	参与者必须： <ul style="list-style-type: none">• 严厉遵守胜会活动之流程或时间表。• 时刻佩戴口罩，并避免与其他参与者有肌体触碰。• 透过MySejahtera手机应用程序，或在记录簿上登记出席记录。
主办单位的责任	主办单位必须： <ul style="list-style-type: none">• 确定胜会活动流程或时间表。• 为胜会场所进行活动前与活动后之消毒工作。• 确保胜会活动场所的空气流通。• 检查参与者的风险评估及接种冠病疫苗的纪录。• 确保参与者只通过一个入口进入及一个出口离开活动场所。• 确保人群时刻遵守一米之社交距离。• 在入口处提供消毒搓手液或水与肥皂。• 确保所有参与者时刻佩戴口罩。• 为所有胜会工作人员与参与者测量体温。• 确保参与者透过MySejahtera手机应用程序，或在记录簿上登记出席记录。• 保持活动场所的整洁。• 委派至少两名工作人员进行监控工作，以确保标准作业程序获得遵守。
